Lee Crawford Pup Extravaganza

UKC Licensed Nite Hunt Deadline: 7 p.m.

Entry Fee: \$75 • 90-minute hunt

**Pup does not need to have previously qualified for this event. Any Walker pup born on or after April 20, 2021 is eligible to compete.**

- This will be a UKC Licensed Event.
- Pup must hunt in their category (Registered, and Champion classes.)
- Must show proof of age (Easy Entry™ Card, Registration Papers, etc.) when a dog is entered.
- Handler and all owners must be paid up TWBFA members for 2023.
- All plus-point cast winners not advancing to the Final Four will receive \$75
- The four highest scoring cast winners with plus points will advance to the Final Four.
- Dogs MUST have plus points to advance to Final Four.
- The Final Four WILL hunt a one-hour hunt-off to determine their placement (separate from UKC Licensed portion of hunt).
- UKC Registered rules will be used on the Final Cast.
- Hunting Judges will be used in early round.
- Non-Hunting Judge to be used on casts with two or less dogs.
- Non-Hunting Judges on the Final Four Cast.
- Hunting and Non-Hunting guides to be used.
- 70% of entry fee revenue will be paid back to cast winners and the Final Four.
- This hunt is a separate hunt held on the same night as the Lee Crawford Invitational.
- Your dog will receive Performance Points (if dog is eligible/paid up).
- Your dog will receive cash for winning a cast and/or placing in the Final Four.
- TWBFA reserves the right to DNA swab/test any dog entered in this event.

Nite Hunt Format: Semi-Final Casts

Top 8 cast winners from early round will draw out into two casts of four dogs Friday and Saturday night. All owner(s) and handler(s), regardless of breed, must be TWBFA members prior to going to woods on early round. Those two semi-final cast winners will advance to the Final Four. Non-Hunting judges will be used.

Final Four Cast Guidelines

1st Place: \$2,500, 2nd Place: \$1,250, 3rd Place: \$750, 4th Place: \$500

All 12 Semi-Final cast entrants not advancing to Final Four will receive \$100.

If no plus point winner on Final Four Cast, then Final Four placements will be determined by plus point scores from Semi-Final Round under non-hunting judges.

Walker Days Champion and Opposite Sex Champion will be determined by highest plus point scores in Final Four. If necessary, revert to previous cast with non-hunting judge.

- Entries must be completed at the TWBFA desk by 5 p.m. (local time).
- Easy Entry™ Card or Proper Registration Papers must be shown at the time of entry.
- Note: Hunting Judges will be used on all early round casts.
- TWBFA reserves the right to merge casts.

Both owner(s) and handler must be a member to receive the King or Queen of Show, High Scoring Male or Female of each night, or High Scoring Walker or Opposite Sex winner of the nite hunt.

As approved by UKC for Chartered Breed Associations only, Grand Nite Champions will be drawn out separately from Nite Champions on Friday and Saturday nights.

**Please note:** No Straw in Barns; Sawdust or Wood Shavings to be used only. This is by order of Fire Marshall!

**Vendor set-up welcome. No fee to reserve your space, first come, first serve.**
