90-minute hunt

*Pup does not need to have previously qualified for this event.*

*Any Walker pup born on or after April 19, 2023 is eligible to compete.*

- All handler and owner(s) must be paid up TWBFA members for 2025
- All plus point cast winners not advancing to the Final Four of the pup hunt will receive \$75
- The four highest plus-point cast winners will advance to the Final Four.
- Dogs MUST have plus points to advance to the Final Four.
- 70% of entry fee revenue will be paid back to cast winners and the Final Four.
- The Final Four will compete in a non-sanctioned one-hour hunt.
- Non-Hunting Judge to be used on casts with two or less dogs.
- Hunting and Non-Hunting guides to be used during first round.
- Non-Hunting Judges and Guides to be used on the Final Four Cast
- TWBFA reserves the right to DNA swab/test any dog entered in this event.

### **\$5,000 Guaranteed Purse Nite Hunt Format**

Top 16 to compete for the \$5000 Guaranteed Purse will consist of the following:

- Slam hunt winners from Thursday and Friday nights
  - TWBFA High-Point Nite Hunt Dog of the year from the 2024 sectionals
  - 4 high Scoring dogs from both Thursday and Friday nights
  - 3 combined double cast winners from Thursday and Friday Nite
- The top 16 will consist of four casts made up of four dogs. All owner(s) and handler(s), regardless of breed, must be TWBFA members prior to going to woods on early round.

### **\$5,000 Guaranteed Purse Final Four Cast Format**

1st Place: \$2,500, 2nd Place: \$1,250, 3rd Place: \$750, 4th Place: \$500

All 12 Semi-Final cast entrants not advancing to Final Four will receive \$100. If no plus-point winner on Final Four Cast, then Final Four placements will be determined by plus-point scores from Semi-Final Rounds. Walker Days Champion and Opposite Sex Champion will be determined by highest plus-point scores in Final Four. If necessary, revert back to semi-final casts for placements.
